A. Events and Quotas

OFFICIALS' QUOTA

The organization committee will take care of the transport and accommodation of 24 additional officials (FILA officials and referees) in order to reach the global quota of 120 participants per IF.

The athletes' accompanying staff (coaches, doctors, masseurs) will be responsible for their own expenses. The organizing committee will however make them benefit from special airfares and accommodation packages.

ATHLETE ELIGIBILITY

To be eligible for the Combat Games, athletes must have been born after 1 January 1990.

Athletes must also be affiliated to a National Federation which is a member of FILA and must possess a 2010 FILA license-insurance.

B. Qualification system

FEMALE WRESTLING

The eight (8) best female wrestlers in the respective categories qualified for the Combat Games at the World Championship that took place in Herning (DEN) from 21 to 27 September 2009.

BELT WRESTLING

Four (4) places were allocated at the World Championship that took place in Siauliai (LTU) from 11 to 13 September 2009. The four (4) remaining places will be allocated at the World Cup that will take place in Vilnius (LTU) from 16 to 19 December 2009.

GRAPPLING AND PANKRATION ATHLIMA

The eight (8) best grapplers and pankratiasts in the respective categories will qualify for the Combat Games at the World Championship that will take place in Cracow (POL) from 26 to 28 March 2010.

C. Reallocation of unused quota places

UNUSED QUOTA PLACES

If a qualified athlete is injured, the National Federation concerned will be responsible for finding a substitute of the same level and proceed to the registration within the allocated time. If no substitute can be found, the place will be allocated to the next best ranked athlete in the category concerned.
